## Registration fees

### **COMPULSORY DOCUMENTS**

#### 4 Compulsory documents to accompany your registration form

➔ 1) Registration form

Underneath filled in and signed

(With a parental authorization for the under 18)

➔ 2) An original medical certificate

With no contra-indications for participating in a windsurfing competition

Dated from less than a year ago on May 8th 2012

➔ 3) Registration fees + temporary permit

Until 20 April 2013: **110 €** registration fees (You have a National sailing permit)

**138 €** (110 € + 28 € registration fees)

(You haven't a National sailing permit

> FRENCH TEMPORARY SAILING PERMIT REQUEST)

From 22 April 2013 **220 €** registration fees

(You have a National sailing permit)

**248 €** (220€ + 28€ registration fees)

➔ 4) A Deposit – Bib Number

A deposit of 30 euros will be requested against delivery bib

- Discard: only 1 heat discarded for the race (from 4 heats validated).
